## No. 5 of 1966

### An Ordinance to provide for the Division and Description of Land in the Territory.

- 1.** This Ordinance may be cited as the *Districts Ordinance* 1966.\* Short title.
- 2.** This Ordinance shall come into operation on a date to be fixed by the Minister by notice published in the *Gazette*.† Commencement.
- 3.** The *Districts Ordinance* 1927 and the *Districts Ordinance* 1949 are repealed. Repeal.
- 4.—(1.)** In this Ordinance, unless the contrary intention appears— Interpretation.
- “deposited plan” means a plan prepared and lodged with the Registrar in accordance with section 7 of this Ordinance;
- “district” means a district referred to in the next succeeding section;
- “the Registrar” means the person for the time being performing the duties of the Registrar of Titles under the *Real Property Ordinance* 1925-1963.
- (2.)** In the Schedule to this Ordinance—
- (a) a reference to a Deposited Plan by number shall be read as a reference to a lodged plan so called and numbered in the office of the Registrar; and
- (b) a reference to land formerly in the State of New South Wales shall be read as a reference to land in that State immediately before the acceptance of that land as part of the Territory.
- 5.—(1.)** The Territory is divided into districts to be known, respectively, as Canberra City, Woden, Belconnen, Gungahlin, Stromlo, Kowen, Hall, Lanyon, Coree, Paddys River, Cotter River, Tennent, Rendezvous Creek, Booth and Mount Clear. Districts.

(2.) The boundaries of each district are the boundaries respectively set out in the Schedule to this Ordinance in relation to that district.

Divisions,  
sections and  
blocks of  
districts.

6.—(1.) The Minister may, by deposited plan, divide a district or portion of a district into divisions, or into sections or blocks.

(2.) The Minister may, by deposited plan, divide a division of a district or portion of a division of a district into sections or blocks.

(3.) The Minister may, by deposited plan, divide a section or portion of a section of a division of a district into blocks.

(4.) The boundaries of each such division, section or block of a district are as delineated in the deposited plan by which the district, division or section is formed under this Ordinance.

(5.) The Minister shall give each division, section or block that is formed by deposited plan under this Ordinance a distinguishing number or name.

(6.) The Minister may, by deposited plan, alter the boundaries or the distinguishing number or name of a division, section or block that is so formed in pursuance of this Ordinance.

Deposited plans.

7.—(1.) For the purposes of this Ordinance, the Minister shall cause a plan to be prepared setting out the boundaries of, and the distinguishing number or name given by him to, each division, section or block that is formed by deposited plan under this Ordinance.

(2.) A plan so prepared shall be presented for lodging at the office of the Registrar.

(3.) The Registrar shall not accept a plan in respect of land the description of which includes a reference to a district, division, section or block for lodging as a deposited plan unless the Commonwealth Surveyor-General has certified on the plan to the effect that the plan has been prepared in accordance with this Ordinance and that the land is correctly so described.

(4.) The Registrar shall endorse or cause to be endorsed on each plan accepted for lodging the time and date of lodging, the words "deposited plan" and a consecutive number in order of lodging.

(5.) The Registrar shall sign a plan that is accepted for lodging and endorsed as provided by this section, or cause to be affixed to such a plan a stamp that is a facsimile of his signature, and the plan thereupon becomes a deposited plan.

(6.) Where the Minister, by an amending deposited plan, alters the boundaries or the number or name of a division, section or block, the Registrar shall endorse or cause to be endorsed on the deposited plan affected by the alteration a note to the effect that the plan has been amended by the specified amending deposited plan on the date of the lodging of the amending deposited plan in accordance with this Ordinance.

(7.) A deposited plan is, unless the contrary is approved, evidence of the measurements and boundaries of the areas of land shown on it.

8. Subject to the *Real Property Ordinance* 1925-1963, the description of a parcel of land by the number or name of the block, section or division, as the case requires, in accordance with the deposited plan on which the parcel of land is shown, and the name of the district in which the land is situated, is a sufficient description of the parcel of land for the purposes of dealings with that land.

Description of land for purposes of dealings.

9.—(1.) Where a deposited plan is lodged in accordance with this Ordinance and the original of an instrument relating to a parcel of land shown in that deposited plan (being an instrument the duplicate of which is bound in the Register Book kept under the *Real Property Ordinance* 1925-1963) is presented to the Registrar, the Registrar shall make such entries, cancellations and corrections on that original instrument, on its duplicate in the Register Book, and on each relevant endorsement on those instruments, as he considers necessary so as to describe that parcel of land by reference to the number or name of the district, division, section or block, as the case may be, by which that parcel of land is described in that deposited plan.

Alterations of instruments.

(2.) The Registrar shall endorse each such altered instrument with a reference to the date of making the alteration and a note to the effect that the instrument has been altered in accordance with this Ordinance and shall sign the endorsement or cause to be affixed to the endorsement a stamp that is a facsimile of his signature.

10. A person may, upon application to the Registrar, inspect a deposited plan at the office of the Registrar at any time during the office hours prescribed by the Registrar of Titles (Office Hours) Regulations made under the *Real Property Ordinance* 1925-1963.

## BELCONNEN DISTRICT

All that part of the Australian Capital Territory commencing at the northernmost corner of Block 2 of Deposited Plan 136; and bounded thence by the eastern boundary of that Block 2, a line, eastern boundaries of Blocks 5 and 7 of Deposited Plan 645 and the southerly prolongation of the eastern boundary of that Block 7 southerly to the middle line of Charnwood Road; thence by part of the middle line of Charnwood Road generally easterly to the middle line of the Barton Highway; thence by part of the middle line of the Barton Highway southeasterly to the generally northwestern boundary of the Canberra City District; thence by part of that boundary generally southwesterly to the intersection of the middle line of the roadway over Scrivener Dam with the middle line of the Molonglo River; thence by part of the middle line of the Molonglo River downstream to a southern boundary of Block 49 of Deposited Plan 673; thence by part of that boundary westerly to a northeastern boundary of Block 13 of Deposited Plan 167; thence by a generally northeastern boundary, a northern boundary and part of a western boundary of Blocks 13 and 11 of Deposited Plan 167 generally northwesterly, westerly and southerly to the middle line of the Molonglo River; thence by part of the middle line of the Molonglo River downstream to the middle line of the Murrumbidgee River; thence by part of the middle line of the Murrumbidgee River downstream to the northwestern boundary of the Territory; thence by part of that boundary northeasterly to the point of commencement

## GUNGALIN DISTRICT

All that part of the Australian Capital Territory commencing at the intersection of the middle line of Sutton Road with the generally northeastern boundary of the Territory; and bounded thence by the middle line of Sutton Road generally southerly to the generally southeastern boundary of the Territory; thence by part of that boundary generally southwesterly to the middle line of the Queanbeyan River; thence by part of the middle line of the Queanbeyan River downstream to the middle line of the Molonglo River; thence by part of the middle line of the Molonglo River downstream to a northeastern boundary of the Canberra City District; thence by generally northeastern and northwestern boundaries of that District generally northwesterly and southwesterly to the middle line of the Barton Highway; thence by part of the middle line of the Barton Highway northwesterly to the middle line of Gundaroo Road; thence by part of the middle line of Gundaroo Road northeasterly to the generally northeastern boundary of the Territory; thence by part of that boundary generally southeasterly to the point of commencement

## STROMLO DISTRICT

All that part of the Australian Capital Territory commencing at the intersection of the middle line of the Murrumbidgee River with the middle line of the Molonglo River; and bounded thence by part of the middle line of the Molonglo River upstream to a western boundary of Block 11 of Deposited Plan 167; thence by western, northern and generally northeastern boundaries of Blocks 11 and 13 of Deposited Plan 167 generally northerly, easterly and southeasterly to the western-most corner of Block 49 of Deposited Plan 673; thence by generally southern, southeastern and southwestern boundaries and part of a generally southern boundary of that Block 49 easterly, northeasterly, southeasterly and easterly to the middle line of the Molonglo River; thence by part of the middle line of the Molonglo River upstream to the middle line of the roadway over Scrivener Dam; thence by generally southwestern, northwestern, southwestern and southern boundaries of the Canberra City District generally southeasterly, southwesterly, southeasterly and easterly to a generally western boundary of Block 25 of Deposited Plan 563; thence by part of that boundary of that Block 25, southern and western boundaries of that Block 25, a western boundary of Block 1 of Deposited Plan 50 and a line generally southerly, easterly and southerly to the middle line of Kambah Road; thence by part of the middle line of Kambah Road easterly to the northerly prolongation of a western boundary of that Block 1; thence by that prolongation, that boundary, northern, western and northern boundaries of Blocks 1 and 29 of Deposited Plan 50 and a line southerly, westerly, southerly and westerly to the middle line of a road 100 links wide; thence by part of the middle line of that road southerly to the easterly prolongation of the northern boundary of Block 4A of Deposited Plan 97; thence by that prolongation, that boundary and a northwestern boundary of that Block 4A and its southwesterly prolongation westerly and southwesterly to the middle line of the Murrumbidgee River; thence by part of the middle line of the Murrumbidgee River downstream to the point of commencement

## KOWEN DISTRICT

All that part of the Australian Capital Territory commencing at the intersection of the middle line of Sutton Road with the generally northeastern boundary of the Territory; and bounded thence by generally northeastern, eastern and southern boundaries of the Territory generally southeasterly, southerly and westerly, respectively, to the middle line of Sutton Road; thence by part of the middle line of Sutton Road generally northerly to the point of commencement

## HALL DISTRICT

All that part of the Australian Capital Territory commencing at the northern-most corner of Block 2 of Deposited Plan 136; and bounded thence by parts of the generally northwestern and northeastern boundaries of the Territory generally north-easterly and southeasterly to the middle line of Gundaroo Road; thence by part of the middle line of Gundaroo Road southwesterly to the middle line of the Barton Highway; thence by part of the middle line of the Barton Highway northwesterly to the middle line of Charnwood Road; thence by part of the middle line of Charnwood Road generally westerly to its intersection with the southerly prolongation of the eastern boundary of Block 7 of Deposited Plan 645; thence by that prolongation, eastern boundaries of Blocks 7 and 5 of Deposited Plan 645, a line and the eastern boundary of Block 2 of Deposited Plan 136 northerly to the point of commencement

## LANYON DISTRICT

All that part of the Australian Capital Territory commencing at the intersection of the middle line of the road separating Block 155 of Deposited Plan 512 from Block 13 of Deposited Plan 577 with a generally eastern boundary of the Territory; and bounded thence by part of that boundary and part of a southern boundary of the Territory generally southerly and westerly to the middle line of the Murrumbidgee River; thence by part of the middle line of the Murrumbidgee River downstream to the southwesterly prolongation of a northwestern boundary

of Block 4A of Deposited Plan 97; thence by that prolongation, that boundary and a northern boundary of that Block 4A and its easterly prolongation northeasterly and easterly to the middle line of a road 100 links wide; thence by part of the middle line of that road northerly to the westerly prolongation of the northern boundary of Block 29 of Deposited Plan 50; thence by that prolongation, part of that boundary, eastern, northern and eastern boundaries of Block 1 of Deposited Plan 50 and a line easterly, northerly, easterly and northerly to the middle line of Kambah Road; thence by part of the middle line of Kambah Road westerly to the southerly prolongation of a western boundary of that Block 1; thence by that prolongation, that boundary, northern, western, northern, eastern, northern, eastern, northern, northeastern and eastern boundaries of Blocks 1 and 27 of Deposited Plan 50 and a line northerly, easterly, northerly, easterly, southerly, easterly, southerly, easterly, southeasterly and southerly, respectively, to the middle line of Kambah Road; thence by part of the middle line of Kambah Road generally easterly to the middle line of the Monaro Highway; thence by part of the middle line of the Monaro Highway northeasterly to the westerly prolongation of a northern boundary of Block 13 of Deposited Plan 577; thence by that prolongation, that boundary, a western boundary of that Block 13 and a line easterly and northerly to the middle line of a road; thence by the middle line of that road easterly to the point of commencement

## COREE DISTRICT

All that part of the Australian Capital Territory commencing at the intersection of the northwestern boundary of the Territory with the middle line of the Murrumbidgee River; and bounded thence by part of the middle line of the Murrumbidgee River upstream to the middle line of the Cotter River; thence by part of the middle line of the Cotter River upstream to the middle line of Coree Creek; thence by part of the middle line of Coree Creek upstream to the easterly prolongation of the northern boundary of Commonwealth land formerly Portions 12, 14 and 15, Parish of Tidbinbilla, County of Cowley, in the State of New South Wales; thence by that prolongation and that boundary westerly to the northwestern corner of that Commonwealth land; thence by a line southwesterly to Coree Trigonometrical Station; thence by part of the northwestern boundary of the Territory northeasterly to the point of commencement

## PADDOYS RIVER DISTRICT

All that part of the Australian Capital Territory commencing at the intersection of the middle line of the Cotter River with the middle line of the Murrumbidgee River; and bounded thence by part of the middle line of the Murrumbidgee River upstream to the middle line of the Gudgenby River; thence by part of the middle line of the Gudgenby River upstream to the easterly prolongation of the southern boundary of land formerly Portion 8, Parish of Tharwa, County of Cowley, in the State of New South Wales; thence by that prolongation, that boundary and a line westerly to the middle line of a road 100 links wide; thence by part of the middle line of that road northerly to the easterly prolongation of a northern boundary of Block 1 of Deposited Plan 203; thence by that prolongation, that boundary, an eastern boundary of that Block 1 and a line westerly and northerly to the middle line of a road 100 links wide; thence by part of the middle line of that road westerly to an eastern boundary of Block 16 of Deposited Plan 203; thence by part of that boundary and the southern and southwestern boundaries of that Block 16 southerly, westerly and generally northwesterly to the southern boundary of land formerly Portion 133, Parish of Tharwa, County of Cowley, in that State; thence by part of that boundary of that last-mentioned land westerly to the eastern boundary of land formerly Portion 46, Parish of Tharwa, County of Cowley, in that State; thence by part of that boundary of that last-mentioned land and a line southerly to the middle line of a road 100 links wide; thence by part of the middle line of that road westerly to the northerly prolongation of the eastern boundary of land formerly Portion 77, Parish of Tharwa, County of Cowley, in that State; thence by that prolongation, that boundary and the southern boundary of that last-mentioned land southerly and westerly to a northeastern boundary of Block 50 of Deposited Plan 203; thence by northeastern, northern, western, northern, eastern, northern and

western boundaries of that Block 50 northwesterly, westerly, southerly, westerly, northerly, westerly and southerly, respectively, to the southeastern corner of land formerly Portions 155 and 156, Parish of Tharwa, County of Cowley, in that State; thence by part of the southern boundary of that last-mentioned land westerly to the northerly prolongation of the eastern boundary of land formerly Portion 10, Parish of Gibraltar, County of Cowley, in that State; thence by that prolongation, that boundary of that last-mentioned land, the southern boundary of that last-mentioned land and a line southerly and westerly to the middle line of a road 100 links wide; thence by the middle line of that road northerly to the middle line of a road separating land formerly Portion 156, Parish of Tharwa, County of Cowley, in that State, from land formerly Portion 4, Parish of Gibraltar, County of Cowley, in that State; thence by part of the middle line of that road westerly and northerly to the easterly prolongation of the northern boundary of that last-mentioned land; thence by that prolongation, that boundary and part of the western boundary of that last-mentioned land westerly and southerly to the easterly prolongation of the northern boundary of land formerly Portion 6, Parish of Gibraltar, County of Cowley, in that State; thence by part of that prolongation westerly to the middle line of a road 100 links wide; thence by the middle line of that road southerly to the easterly prolongation of the southern boundary of land formerly Portion 5, Parish of Gibraltar, County of Cowley, in that State; thence by that prolongation, that boundary and a line westerly to the divide between the watersheds of the Cotter River on the west and Paddys River on the east; thence by part of that divide and a line generally northerly to the middle line of the Cotter River; thence by part of the middle line of the Cotter River downstream to the point of commencement

## COTTER RIVER DISTRICT

All that part of the Australian Capital Territory commencing at Coree Trigonometrical Station; and bounded thence by a line northeasterly to the north-western corner of Commonwealth land formerly Portions 12, 14 and 15, Parish of Tidbinbilla, County of Cowley, in the State of New South Wales; thence by the northern boundary of that Commonwealth land and its easterly prolongation easterly to the middle line of Coree Creek; thence by part of the middle line of Coree Creek downstream to the middle line of the Cotter River; thence by part of the middle line of the Cotter River downstream to the northerly prolongation of the divide between the watershed of the Cotter River on the west and the watersheds of Paddys River and the Gudgenby River on the east; thence by that prolongation and that divide generally southerly to Mount Kelly Trigonometrical Station; thence by a south-eastern boundary and part of a western boundary of the Territory generally southwesterly and northerly to the point of commencement

## TENNETT DISTRICT
