For identified courses OTAE may determine a revised tuition fee for specific target groups in accord with ACT Vocational Education and Training Authority priorities and with recommendations and priorities of ACT vocational education and training strategies for women, people with disabilities and indigenous people. RTOs will be able to negotiate a revised price for these identified courses.
