

Waste Minimisation (Landfill Fees) Determination 2008 (No 1)

Disallowable Instrument DI2008-111

Made under the

Waste Minimisation Act 2001, Section 45(1) - Determination of Fees

1. Name of instrument

This instrument is the Waste Minimisation (Landfill Fees) Determination 2008 (No 1).

2. Commencement

This instrument commences on 1 July 2008.

3. Revocation of previous determination

Disallowable Instrument DI2007 – 144 (Waste Minimisation (Landfill Fees) Determination 2007 (No 1)) is revoked.

4. Determination of fees

The fee payable in respect of each matter listed in an item in Column 2 of the Schedule is the amount listed for that item in Column 4 of the Schedule.

5. Payment of fees

A fee listed in the Schedule is payable to the Territory by the person requesting the good or service listed.

6. Fee Waivers

The Minister may waive a fee listed in Part 2 of the Schedule if it is in the public interest to do so.

7. Goods and services tax

Where applicable, GST inclusive fees in the Schedule are marked with a double asterisk (**).
