AN ORDINANCE

To amend the Canberra Community Hospital Ordinance 1938-1944.

BE it ordained by the Deputy of the Governor-General in and over the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the Seat of Government Acceptance Act 1909-1938 and the Seat of Government (Administration) Act 1910-1940, as follows:—

- 1.—(1.) This Ordinance may be cited as the Canberra Short title and citation, Community Hospital Ordinance 1945.*
- (2.) The Canberra Community Hospital Ordinance 1938-1944 is in this Ordinance referred to as the Principal Ordinance.
- (3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the Canberra Community Hospital Ordinance 1938-1945.
- 2. Section six of the Principal Ordinance is amended by omit-constitution ting from sub-section (1.) the word "who" and inserting in its stead the words "of whom one shall be appointed by the Minister and five".
- 3. Section seven of the Principal Ordinance is amended by Election of omitting from sub-section (1.) the word "six" and inserting in its Members. stead the word "five".
 - 4. Section twenty-one of the Principal Ordinance is amended— Meetings of the Board.
 - (a) by inserting after sub-section (5.) the following subsections:—

"(5A.) At the first meeting of the Board after the commencement of the Canberra Community Hospital Ordinance 1945, and at the first meeting of the Board after each election, or after the occurrence of any vacancy in the office of Deputy Chairman, the members shall elect a Deputy Chairman who shall, subject to his continuing to be a member, hold office until a Deputy Chairman is elected at the first meeting of the Board after the next succeeding election.

- "(5B.) In the case of the illness or absence of the Chairman, the Deputy Chairman shall have and may exercise all the powers and functions of the Chairman.";
- (b) by inserting in sub-section (6.), after the word "Chairman", the words "and the Deputy Chairman": and
- (c) by omitting from sub-section (7.) the words "or person acting as Chairman" and inserting in their stead the words "Deputy Chairman or person acting as Chairman at any particular meeting,".

Expenditure by the Board.

- 5. Section twenty-eight of the Principal Ordinance is amended by omitting from paragraph (c) of sub-section (1) the words "for sick or infirm persons who are not inmates of the Hospital" and inserting in their stead the words ", and dental services for persons admitted to the Hospital as in-patients or out-patients";
- **6.** After section thirty-one of the Principal Ordinance, the following section is inserted:—

Charges for dental services.

"31a. Subject to section thirty-seven of this Ordinance, a person shall be liable to pay to the Board in respect of dental services rendered to him such charges as are prescribed, but not exceeding in any case the actual cost of such services."

Liability of patients.

7. Section thirty-two of the Principal Ordinance is amended by adding at the end of the definition of "treatment" in sub-section (8.) the words "and includes dental services".

Statement of amount due.

8. Section thirty-six of the Principal Ordinance is amended by inserting after the word "section" the word and letter "thirty-one A,".

By-laws.

9. Section forty of the Principal Ordinance is amended by inserting in paragraph (e) of sub-section (1.), after the word "duties", the words "and conduct".

Repeal of Second Schedule. 10. The Second Schedule to the Principal Ordinance is repealed and the following Schedule inserted in its stead:—

"SECOND SCHEDULE. DESCRIPTION OF LAND.

All that piece of land at Acton Canberra Australian Capital Territory containing an area of 8 acres 1 rood 25 perches more or less commencing at the westernmost corner of the block on which is situated the residence of the Medical Superintendent and bounded thence by northwestern northeastern and southeastern boundaries of that block 51 degrees 13 minutes 20 seconds \$19.61 feet, 56.55 feet by an arc of a circle of radius 30 feet the chord of which bears 105 degrees 13 minutes 20 seconds 48.54 feet and the centre of which lies to the southwest, 159 degrees 13 minutes 20 seconds 80.61 feet and 205 degrees 37 minutes 51.7 feet thence generally southeasterly and southwesterly by a fenced line a line fenced lines and a line 118 degrees 46 minutes 20 seconds 244.36 feet 157 degrees 58 minutes 54.35 feet 120 degrees 49 minutes 20 seconds 665.9 feet 112 degrees 11 minutes 40 seconds 168.34 feet 171 degrees 44 minutes 20 seconds 117.5 feet 192

degrees 18 minutes 30 seconds 120.2 feet 201 degrees 26 minutes 47.1 feet 217 degrees 17 minutes 113.25 feet and 265 degrees 57 minutes 65 feet to a point on the northeastern kerb of the Lennox Crossing roadway thence generally northwesterly by that kerb and generally northeasterly by the southeastern kerb of the carriageway leading to the Nurses' Home 310 degrees 17 minutes 18.7 feet, 121.45 feet by an arc of a circle of radius 1250 feet the chord of which bears 307 degrees 30 minutes 121.4 feet and the centre of which lies to the southwest, 304 degrees 43 minutes 115.42 feet, 16.55 feet by an arc of a circle of radius 15 feet the chord of which bears 337 degrees 39 seconds 15.73 feet and the centre of which lies to the northeast, 50.43 feet by an arc of a circle of radius 64 feet the chord of which bears 31 degrees 12 minutes 11 seconds 49.10 feet and the centre of which lies to the southeast thence by a line bearing 305 degrees 23 minutes 35 seconds 293.1 feet to the westernmost corner of the ramp at the southern entrance to the hospital thence by a line bearing 298 degrees 18 minutes 25 feet to the easternmost point of the footpath from the Hospital Outpatients' Entrance to the residence of the Medical Superintendent thence by northeastern sides and the line of northeastern sides of that footpath generally northwesterly 304 degrees 57 minutes 40 seconds 299.4 feet, 89.25 feet by an arc of a circle of radius 215 feet the chord of which bears 316 degrees 51 minutes 10 seconds 88.61 feet and the centre of which lies to the northeast, 328 degrees 44 minutes 40 seconds 35.32 feet 328 degrees 23 minutes 20 seconds 199.3 feet 330 degrees 59 minutes 38.3 feet 336 degrees 19 minutes 23 seconds 102.6 feet and 342 degrees 5 minutes 20 seconds 56.2 feet to the point of commencement."
