# COMPANIES (AMENDMENT) ORDINANCE 1980

#### Short title

1. This Ordinance may be cited as the Companies (Amendment) Ordinance 1980.1

### **Principal Ordinance**

2. In this Ordinance, "Principal Ordinance" means the Companies Ordinance 1962.<sup>2</sup>

#### Commencement

3. This Ordinance shall come into operation on 1 April 1980.

### Repeal

4. Section 349 of the Principal Ordinance is repealed.
