AMENDMENTS OF THE COMPANIES REGULATIONS!

1. Regulation 8 of the Companies Regulations is amended by omitting General paragraph (a) and substituting the following paragraph:---

requirements for documents lodged with the Registrar.

- "(a) the document shall be on paper of medium weight and good quality and—
 - (i) in the case of a document on paper of less than foolscap folio size—not less than 8½ inches deep by 5½ inches wide; and
 - (ii) in any other case---of foolscap folio size or a multiple of that size:".
- 2. Regulation 9 of the Companies Regulations is amended by omitting from verification and sub-regulation (6) the words "one of the persons" and substituting the words documents. "each of the persons".

3. Regulation 10 of the Companies Regulations is amended—
