An Act for the Revision of certain Acts of the Australian Capital Territory

**Short title**

1. This Act may be cited as the *Acts Revision Act 1959*.<sup>1</sup>

**Commencement**

2. This Act shall come into operation on the thirty-first day of December, One thousand nine hundred and fifty-nine.

**Amendment of Acts**

- 3.<sup>2</sup> The Acts specified in the first column of the Schedule to this Act are amended as respectively specified in the second column of that Schedule.
