ORDINANCES REVISION (DECIMAL CURRENCY)

No. 19 of 1966

An Ordinance to revise the Ordinances of the Australian Capital Territory in consequence of the adoption of Decimal Currency.

Short title.

1. This Ordinance may be cited as the Ordinances Revision (Decimal Currency) Ordinance 1966.*

Amendments of Ordinances.

2. The Ordinances specified in the First Schedule to this Ordinance are amended as set out in that Schedule.

Citations of amended Ordinances.

3. An Ordinance specified in the first column of the Second Schedule to this Ordinance, as amended by this Ordinance, may be cited in the manner specified in the second column of that Schedule opposite to the reference to that Ordinance in the first column.

Amendments of N.S.W. Games Wagers and Betting-

- 4.—(1.) In this section, "the Games Wagers and Bettinghouses Act 1901" means the Games Wagers and Bettinghouses Act 1901 of the State of New South Wales in its application to the Territory as amended by the Gaming and Betting Act, 1906 of that State in its application to the Territory, and by the Games, Wagers and Betting-houses Ordinance 1964.
