### **An Act to revise the statute law of the Territory**

*[Notified in ACT Gazette S93: 31 May 1994]*

The Legislative Assembly for the Australian Capital Territory enacts as follows:

#### **Short title**

1. This Act may be cited as the *Statute Law Revision Act 1994*.

#### **Commencement**

2. This Act commences on the day on which it is notified in the *Gazette*.

#### **Amendments of Acts**

#### **Repeal**
