Statute Law Revision (Penalties) Act 1994

No. 81 of 1994

An Act to revise the statute law of the Territory in relation to penalties and for related penalties

[Notified in ACT Gazette S253: 29 November 1994]

The Legislative Assembly for the Australian Capital Territory enacts as follows:

PART I—PRELIMINARY

Short title

1. This Act may be cited as the *Statute Law Revision (Penalties) Act 1994*.

Commencement

2. (1) Section 1 and this section commence on the day on which this Act is notified in the *Gazette*.

(2) Section 3 commences on a day fixed by the Minister by notice in the *Gazette*.

(3) If section 3 has not commenced before the end of the period of 6 months commencing on the day on which this Act is notified in the *Gazette*, that section, by force of this subsection, commences on the first day after the end of that period.
