# **Financial Management Amendment Act 2001**

#### No 4 of 2001

# An Act to amend the Financial Management Act 1996

[Notified in ACT Gazette No 10: 8 March 2001]

The Legislative Assembly for the Australian Capital Territory enacts as follows:

### 1 Short title

This Act may be cited as the *Financial Management Amendment Act* 2001.

#### 2 Commencement

- (1) Sections 1, 2 and 3 commence on the day on which this Act is notified in the Gazette.
- (2) Section 4 commences on a day fixed by the Minister by notice in the Gazette.
- (3) If section 4 has not commenced before the end of the period of 6 months commencing on the day on which this Act is notified in the Gazette, that provision, by force of this subsection, commences on the first day after the end of that period.

## 3 Principal Act

In this Act, "Principal Act" means the *Financial Management Act* 1996.<sup>1</sup>

# 4 Territory budgets

Section 11 of the Principal Act is amended by adding at the end the following subsections:

- "(4) A proposed budget for the Territory for a financial year shall be prepared taking into account the principles of responsible fiscal management specified in subsection (5).
- "(5) The principles of responsible fiscal management are—
  - (a) ensuring that the total liabilities of the Territory are at prudent levels so as to provide a buffer against factors that may impact adversely on the level of total Territory liabilities in the future, and ensuring that, until such levels have been achieved, the total operating expenses of the Territory in each financial year are less than its operating levels revenues in the same financial year;
  - (b) when prudent levels of total Territory liabilities have been achieved, maintaining these levels by ensuring that, on average, over a reasonable period of time, the total operating expenses of the Territory do not exceed its operating levels revenues;
  - (c) achieving and maintaining levels of Territory net worth that provide a buffer against factors that may impact adversely on that net worth in the future; and
  - (d) managing prudently the fiscal risks of the Territory.
- "(6) The proposed budget may depart from the principles specified in subsection (5), but when it does so—
  - (a) any departure shall be temporary; and
  - (b) the Treasurer shall cause to be laid before the Legislative Assembly, at the same time as the first Appropriation Bill relating to the financial year to which the departure relates is introduced into the Legislative Assembly—
    - (i) the reasons for the departure;
    - (ii) the approach intended to be taken to return to the principles;
    - (iii) the period of time expected to be taken to return to those principles.".
