An application for the issue of a Second-hand Dealers Licence must be in the approved form. This document is the approved form for the purposes of applications under the Second-hand Dealers Act 1906. The relevant fee for your licence must accompany the application.

Your application must also be accompanied by a "Consent to Obtain Personal Information" form which enables the Australian Federal Police to provide relevant information, if any, about each of the "Executive Officers" of the company, from the records of the Australian Federal Police and/or the Police Services of all or any of the States and Territories of the Commonwealth of Australia.

A separate form is required for each "Executive officer" of the Company. You must provide a copy of a driver's licence or some other form of official photographic identity for each "Executive Officer" (to assist you, we will make a copy of their original documents of identity for this purpose). You must pay a fee for these police records checks at the time of lodging your application for the second-hand dealers licence.

A licence will not be issued to the Company until the police records checks have been returned to us and the Commissioner of Fair Trading, or a delegate of the Commissioner, has approved your application. The Commissioner must be satisfied that each "Executive Officer" is a "suitable person" within the meaning of the Second-hand Dealers Act 1906, before approving your application.

"Executive Officer" means a person, by whatever name called and whether or not the person is a director of the corporation, who is concerned with, or takes part in, the corporation's management.
