

# ACT HERITAGE REGISTER— CANCELLATION FORM

## The ACT Heritage Register contains details of places and objects of significance to the ACT protected under ACT law.

This form is for a cancellation proposal, in part or whole, of the heritage registration of a place or object under the *Heritage Act 2004 (Part7)*.

You are asked to identify the loss of registered heritage values and provide supporting evidence. Each cancellation proposal will be publicly notified as well as being forwarded to each interested person (*Heritage Act 2004* s13). It will have a four-week consultation period with public comments invited.
