YOU MUST KEEP THIS RECEIPT

This receipt authorises the named person as the consumer to possess, use and transport the bags of fireworks shown on this receipt. This authority does not apply if the weight of the fireworks shown below, together with any other fireworks purchased by the consumer in the year of issue, exceeds 25kgs. Discharge of these fireworks may only take place between 5pm - 9pm Saturday and Sunday of the Queen's Birthday long weekend in the year of issue at the location shown. Use, storage or transport of consumer fireworks after 9pm on the Sunday of the Queen's Birthday long weekend is not permitted.

Important information for buyers

- Fireworks must not be used in a way that endangers or injures any person or animal, or damages any property.
- Fireworks must not be used on unleased ACT land without prior approval.
- Fireworks must not be used during a total fire ban. It is your responsibility to check fire ban status.
- All fireworks must be transported, stored and used as per the instructions supplied at purchase.
- It is an offence to possess or use fireworks without an authority: max. penalty \$75,000 and/or 3 years imprisonment.
- You must not purchase, transport or store more than 25kgs of consumer fireworks.
