## INFORMATION ABOUT TRESPASS APPLICATIONS

This Application form should be used for applications to the ACT Civil and Administrative Tribunal (the ACAT) for trespass actions.

A 'trespass' is an unauthorised, uninvited entry onto your land. If a person remains on your land after being told to leave the person is trespassing.

You can apply for particular orders to deal with a trespass. An example is an application for an order requiring a squatter to leave your land. You can also recover monetary damages.

Other applications should be lodged in person between the hours of 9am and 4.30pm at the ACAT, Level 4, ACT Health Building, 1 Moore Street, Canberra City or by mail to GPO Box 370, Canberra ACT 2601 or by fax to (02) 6205 4855
