



## NOTICE OF ELECTION TO BE ASSESSED UNDER SECTION 276D FOR LEASE VARIATION CHARGE

This notice is to be used when the applicant for a development application (DA) wishes to have the change of use charge determined under section 276D of the *Planning and Development Act 2007*. This form is taken to be notice to the commissioner for revenue.

The following conditions **must** be met in order to transfer to the new provisions:

- The development application involving a proposal to vary a Crown lease was lodged, with fees being paid, prior to 1 July 2011;
- The change of use charge had not yet been determined by the Planning and Land Authority prior to the date of making this application; and
- This application is made by the DA applicant before 1 October 2011.
