**An Act to amend certain Acts in consequence of the
enactment of the *Registrar-General Act 1993* and for
related purposes**

The Legislative Assembly for the Australian Capital Territory enacts as
follows:

PART I—PRELIMINARY

Short title

- 5 **1.** This Act may be cited as the *Registrar-General (Consequential
Provisions) Act 1993*.

Commencement

- 2. (1)** Section 1 and this section commence on the day on which this
Act is notified in the *Gazette*.

(2) The remaining provisions commence on the day on which the provisions of the *Registrar-General Act 1993* (other than sections 1 and 2) commence.

Interpretation

5 3. In this Act, unless the contrary intention appears—

“commencement day” means the day on which the *Registrar-General Act 1993* (other than sections 1 and 2) commences;

10 “Deputy Registrar” means a Deputy Registrar of Births, Deaths and Marriages, a Deputy Registrar of Business Names, a Deputy Registrar of Securities or a Deputy Registrar of Titles, as the case requires;

15 “Registrar” means the Registrar of Births, Deaths and Marriages, the Registrar of Business Names, the Registrar of Incorporated Associations, the Registrar of Securities, the Registrar of Titles or the Registrar of Unclaimed Moneys, as the case requires.

PART II—CONSEQUENTIAL AMENDMENTS

Amendment of Acts

PART III—TRANSITIONAL PROVISIONS

Acts of a Registrar

25 6. An act or thing done by, on behalf of, or in relation to, a Registrar or Deputy Registrar, before the commencement day shall, on and after the commencement day, be taken to have been done by, on behalf of, or in relation to, the Registrar-General.

Service on a Registrar

30 7. A document or other thing given to, served on, or lodged with, a Registrar or Deputy Registrar shall, on and after the commencement day, be taken to have been given to, served on, or lodged with, the Registrar-General.

Instruments

5 8. An instrument made, granted or issued by a Registrar or Deputy Registrar before the commencement day and in force immediately before that day, has effect on and after that day (except in relation to matters that occurred before that day) as if it had been made, granted or issued by the Registrar-General.

References in instruments

10 9. A reference to a Registrar or Deputy Registrar in any instrument made, granted or issued before the commencement day and in force immediately before that day has effect, on and after that day, as if the reference were (except in relation to matters that occurred before that day) a reference to the Registrar-General.

Contracts and agreements

15 10. A contract or agreement entered into by a Registrar or Deputy Registrar and in force immediately before the commencement day continues in force on and after that day as if—

- (a) the Registrar-General were substituted for the Registrar or Deputy Registrar as a party to the contract or agreement; and
- 20 (b) any reference in the contract or agreement to the Registrar or Deputy Registrar were (except in relation to matters that occurred before that day) a reference to the Registrar-General.

Legal proceedings

25 11. (1) Where, before the commencement day, a cause of action by or against a Registrar or Deputy Registrar had arisen but proceedings in respect of that cause of action had not been instituted before that day, such proceedings may be instituted by or against the Registrar-General.

30 (2) Where, before the commencement day, proceedings had been instituted by or against a Registrar or Deputy Registrar in a court, tribunal, commission or other body but those proceedings had not been completed before that day, those proceedings may be continued by or against the Registrar-General.

35 (3) In proceedings instituted or continued under this section, each party to the proceedings has the same rights, and is subject to the same obligations, as if the Registrar-General were the Registrar or Deputy Registrar, as the case requires, and the proceedings had been instituted or continued by or against the Registrar or Deputy Registrar, as the case requires.

Rights and liabilities

- 5 **12.** The rights, privileges, obligations and liabilities of a Registrar or Deputy Registrar existing immediately before the commencement day are, on and after that day, the rights, privileges, obligations and liabilities of the Registrar-General.

Certificates as evidence

- 10 **13.** A certificate issued by a Registrar or Deputy Registrar and in force immediately before the commencement day, is, on and after that day (except in relation to matters that occurred before that day), evidence of the matters stated in the certificate as if it had been issued by the Registrar-General.
