**An Act to amend certain Acts consequent on the  
making of the *Workers' Compensation (Amendment)  
Act 1991***

The Legislative Assembly for the Australian Capital Territory enacts as follows:

**Short title**

- 5 1. This Act may be cited as the *Workers' Compensation (Consequential Amendments) Act 1991*.

**Commencement**

2. (1) Section 1 and this section commence on the day on which this Act is notified in the *Gazette*.
- 10 (2) The remaining provisions commence on the day on which section 5 of the *Workers' Compensation (Amendment) Act 1991* commences.

**Section 2—**

- (a) From the definition of “employer” omit “*Workmen's*”.
- (b) From the definition of “employer's policy”—
  - (i) omit “*Workmen's*”; and
  - (ii) omit “workman employed by him”, substitute “worker employed by the employer”.
- (c) From the definition of “Fund” omit “*Workmen's*”, substitute “*Workers'* ”.
- (d) Omit the definition of “insurer”, substitute the following definition:

“ ‘insurer’ means an approved insurer within the meaning of the Compensation Act;”.
- (e) Omit the definitions of “workman” and “*Workmen's Compensation Act*”.
- (f) Insert the following definitions:

“ ‘Compensation Act’ means the *Workers' Compensation Act 1951*;

‘worker’ has the same meaning as in the Compensation Act.”.

**Subsections 3 (1) and (4)—**

Omit “*Workmen's*”, substitute “*Workers'* ”.

**Subsections 23 (1) and (2)—**

- (a) Omit “subsection 18 (2)”, substitute “section 17C”.
- (b) Omit “*Workmen's*”.

**Paragraph 26 (1) (a)—**

- (a) Omit “his” (wherever occurring), substitute “the employer's”.
- (b) Omit “*Workmen's*”.
- (c) Omit “workman employed by him”, substitute “worker employed by the employer”.
