## **Statute Law Amendment Bill 2012**

---

### **A Bill for**

An Act to amend legislation for the purpose of statute law revision

---

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1 **1 Name of Act**

2 This Act is the *Statute Law Amendment Act 2012*.

3 **2 Commencement**

4 (1) This Act commences on the 14th day after its notification day.

5 *Note* The naming and commencement provisions automatically commence on  
6 the notification day (see Legislation Act, s 75 (1)).

7 (2) However, a date or time provided by a special commencement  
8 provision for an amendment made by this Act has effect as the  
9 commencement date or time of the amendment.

10 (3) In this section:

11 *special commencement provision*, for an amendment made by this  
12 Act, is a provision, in brackets beginning with the text  
13 ‘commencement:’, at the end of the amendment.

14 **Example**

15 An amendment followed by ‘(commencement: the later of the commencement of  
16 this Act and the *Justice and Community Safety Legislation Amendment Act 2012*,  
17 schedule 1, part 1.5)’ means that the amendment commences on the later of the  
18 commencement of this Act and the *Justice and Community Safety Legislation*  
19 *Amendment Act 2012*.

20 *Note* An example is part of the Act, is not exhaustive and may extend, but  
21 does not limit, the meaning of the provision in which it appears (see  
22 Legislation Act, s 126 and s 132).

23 **3 Purpose of Act**

24 The purpose of this Act is to improve the quality of the statute law  
25 of the Territory by amending legislation for the purpose of statute  
26 law revision.

1 **4 Notes**

2 A note included in this Act is explanatory and is not part of this Act.

3 *Note* See the Legislation Act, s 127 (1), (4) and (5) for the legal status of  
4 notes.

5 **5 Legislation amended—schs 1-3**

6 This Act amends the legislation mentioned in schedules 1 to 3.

3 **Part 1.1** **Cultural Facilities Corporation**  
4 **Act 1997**

5 **[1.1] Section 6 (d)**

7 Minister is responsible for approving providers to provide courses to

10 **Explanatory note**

11 This amendment replaces the ‘council chairperson’ with the ‘Minister’ as the designated  
12 authority for the purposes of the *Education Services for Overseas Students Act 2000* (Cwlth).  
13 This amendment also limits the provision to providers of courses to overseas students at  
14 government or non-government schools.

15 The amendment is necessary because the role of the Accreditation and Registration Council  
16 (established under the *Training and Tertiary Education Act 2003*, section 7), in relation to  
17 vocational education and training and higher education providers, is being overtaken by entities  
18 under Commonwealth legislation. The Australian Skills and Quality Authority established  
19 under the *National Vocational Education and Training Regulator Act 2011* (Cwlth) is the  
20 designated authority in the Territory in relation to vocational education training. The Tertiary  
21 Education Quality and Standards Agency established under the *Tertiary Education Quality and*  
22 *Standards Agency Act 2011* (Cwlth) will be the designated authority in the Territory in relation  
23 to higher education providers. Given the diminished role of the council, it is considered more  
24 appropriate for someone other than the council chairperson to be the designated authority to  
25 approve providers of courses to overseas students at schools. As the Minister is already  
26 responsible under the *Education Act 2004* for establishing schools and approving the  
27 registration of non-government schools for domestic students, it is considered appropriate for  
28 the Minister to approve providers of courses for overseas students at the same schools.
