## **NRMA—ACT Road Safety Trust Repeal Bill 2015**

---

### **A Bill for**

An Act to repeal the *NRMA—ACT Road Safety Trust Act 1992*, and for other purposes

---

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1 **1 Name of Act**

2 This Act is the *NRMA—ACT Road Safety Trust Repeal Act 2015*.

3 **2 Commencement**

4 This Act commences on the day after its notification day.

5 *Note* The naming and commencement provisions automatically commence on  
6 the notification day (see [Legislation Act](#), s 75 (1)).

7 **3 Legislation repealed**

8 (1) The *NRMA—ACT Road Safety Trust Act 1992* (A1992-40) is  
9 repealed.

10 (2) All legislative instruments under the *NRMA—ACT Road Safety*  
11 *Trust Act 1992* are repealed.

12 **4 Road Transport (General) Act 1999**  
13 **New part 14**

15 **Part 14 Transitional—NRMA—ACT Road**  
16 **Safety Trust Repeal Act 2015**

17 **304 Meaning of *commencement day*—pt 14**

18 In this part:

19 *commencement day* means the day the *NRMA—ACT Road Safety*  
20 *Trust Repeal Act 2015*, section 4 commences.

1   **305       Trust to be charitable**

2       (1) The repealed section continues to apply.

3       (2) In this section:

4           *repealed section* means the *NRMA—ACT Road Safety Trust*  
5           *Act 1992*, section 5 (Trust to be charitable), as in force immediately  
6           before the commencement day.

7       (3) This section expires 3 years after the commencement day.

8   **306       Exemption from liability**

9       (1) The repealed section continues to apply to acts or omissions  
10       occurring before the termination of the trust regardless whether the  
11       acts or omissions occurred on or after the commencement day.

12       (2) In this section:

13           *repealed section* means the *NRMA—ACT Road Safety Trust*  
14           *Act 1992*, section 6 (Exemption from liability), as in force  
15           immediately before the commencement day.

16           *trust*—see the *NRMA—ACT Road Safety Trust Act 1992*, dictionary,  
17           definition of *trust*, as in force immediately before the  
18           commencement day.

19       (3) This section expires 15 years after the commencement day.

20   **307       Expiry—pt 14**

21       This part (other than section 305) expires 15 years after the  
22       commencement day.

23       *Note*     Transitional provisions are kept in the Act for a limited time.  
24                A transitional provision is repealed on its expiry but continues to have  
25                effect after its repeal (see [Legislation Act](#), s 88).
