ACT Civil and Administrative Tribunal Amendment Bill 2016 (No 2)

A Bill for

An Act to amend the *ACT Civil and Administrative Tribunal Act 2008*, and for other purposes

The Legislative Assembly for the Australian Capital Territory enacts as follows:

- 1 **1 Name of Act**
- 2 This Act is the *ACT Civil and Administrative Tribunal Amendment*
3 *Act 2016 (No 2)*.
- 4 **2 Commencement**
- 5 (1) This Act (other than the following provisions) commences on the
6 day after its notification day:
- 7 • section 4;
8 • schedule 1, amendments 1.7 and 1.8;
9 • schedule 1, part 1.5.
- 10 *Note* The naming and commencement provisions automatically commence on
11 the notification day (see [Legislation Act](#), s 75 (1)).
- 12 (2) Section 4 and schedule 1, part 1.5 (Magistrates Court Act 1930)
13 commence 6 months after this Act's notification day.
- 14 (3) Schedule 1, part 1.4 (Judicial Commissions Act 1994), amendments
15 1.7 and 1.8 commence immediately after the commencement of the
16 *Judicial Commissions Amendment Act 2015*, section 3.
- 17 **3 Legislation amended**
- 18 This Act amends the *ACT Civil and Administrative Tribunal*

94 Appointment of presidential members

(1) The Executive may appoint—

(a) a president of the tribunal; and

(b) other presidential members of the tribunal.

Note For the making of appointments (including acting appointments), see the [Legislation Act](#), pt 19.3.

(2) Also, the Executive may appoint a person as—

(a) a temporary president of the tribunal; or

(b) a temporary other presidential member of the tribunal.

(3) The Executive must not appoint a person under subsection (1) (a) or (2) (a) unless—

(a) the person is—

(i) a magistrate; or

(ii) eligible to be appointed as a magistrate; and

(b) if the person is a magistrate—

(i) the person has agreed to the appointment; and

(ii) the Chief Magistrate has been consulted about the person's appointment.

Note Magistrates are appointed by the Executive under the [Magistrates Court Act 1930](#), s 7. For eligibility for appointment as a magistrate, see that Act, s 7AA and s 7A.

- 1 (4) The appointment of a magistrate as president of the tribunal does
2 not—
- 3 (a) affect the term or conditions of appointment of the magistrate;
4 or
- 5 (b) prevent the magistrate from exercising the functions given to a
6 magistrate under any territory law.
- 7 (5) The Executive must not appoint a person under subsection (1) (b)
8 or (2) (b) unless the person is a lawyer and has been a lawyer for
9 5 years or more.
- 10 (6) The appointment of a presidential member is a notifiable instrument.

11 *Note* A notifiable instrument must be notified under the [Legislation Act](#).

- 16 (1) The president is responsible for ensuring—
17 (a) that decisions are made according to law; and
18 (b) the orderly and prompt discharge of tribunal business.

22 members, including by maintaining skills and resources for that purpose

Examples—par (b)

- 1 allocating people to make up a tribunal for a particular application
- 2 allocating people to make up an appeal tribunal

Note An example is part of the Act, is not exhaustive and may extend, but does not limit, the meaning of the provision in which it appears (see [Legislation Act](#), s 126 and s 132).

- (2) The president may delegate the president’s functions under this Act to another presidential member.

- (1) This section applies to the person who, immediately before the day the *ACT Civil and Administrative Tribunal Amendment Act 2016 (No 2)*, section 5 commences, was the general president of the tribunal.
- (2) The person is taken to be appointed as the president of the tribunal on the same conditions that applied to the person's appointment as general president.

361 **Transitional regulations**

6 **470 Existing proceedings in Magistrates Court**

- 7 (1) This section applies to a proceeding in relation to a civil dispute if—
- 8 (a) the amount claimed, or the amount sought to be declared as a
9 debt, is at least \$10 000 but not more than \$25 000; and
- 10 (b) the proceeding started in the Magistrates Court before the
11 commencement day; but
- 12 (c) immediately before the commencement day, the hearing in the
13 proceeding had not started.
- 14 (2) The proceeding may—
- 15 (a) continue in the Magistrates Court; or
- 16 (b) on application by a party to the proceeding—be transferred to
17 the ACAT if the Magistrates Court—
- 18 (i) considers it just to do so; and
- 19 (ii) makes an order to transfer the proceeding.
- 20 (3) In deciding whether to transfer a proceeding (the *existing*
21 *proceeding*), the Magistrates Court must consider whether there is
22 another proceeding about a matter associated with the existing
23 proceeding before the Magistrates Court.
