Statute Law Amendment Bill 2022

A Bill for

An Act to amend legislation for the purpose of statute law revision, and for other purposes

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1 **1 Name of Act**

2 This Act is the *Statute Law Amendment Act 2022*.

3 **2 Commencement**

4 This Act commences on the 14th day after its notification day.

5 *Note* The naming and commencement provisions automatically commence on
6 the notification day (see [Legislation Act](#), s 75 (1)).

7 **3 Notes**

8 A note included in this Act is explanatory and is not part of this Act.

9 *Note* See the [Legislation Act](#), s 127 (1), (4) and (5) for the legal status of notes.

10 **4 Purpose of Act**

11 The purpose of this Act is to improve the quality of the statute law of
12 the Territory by amending legislation for the purpose of statute law
13 revision.

14 **5 Legislation amended—schs 1-3**

15 This Act amends the legislation mentioned in schedules 1 to 3.

13 The words ‘except on leave given by the Minister’ create a requirement for the Minister to
14 approve the director’s leave if the director intends to be on leave for longer than 14 consecutive
15 days or for 28 days in any 12-month period. While the director’s appointment to the position of
16 director of territory records is made under the *Territory Records Act 2002*, part 4 (Director of
17 Territory Records), the director is employed as an SES member under the *Public Sector*
18 *Management Act 1994*.
