A Bill for

An Act to amend legislation about road safety, and for other purposes

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1 **Part 1 Preliminary**

2 **1 Name of Act**

3 This Act is the *Road Safety Legislation Amendment Act 2022*.

4 **2 Commencement**

5 (1) This Act (other than part 3) commences on the day after its
6 notification day.

7 *Note* The naming and commencement provisions automatically commence on
8 the notification day (see [Legislation Act](#), s 75 (1)).

9 (2) Part 3 commences 12 months after this Act's notification day.

- 4 (ii) with a prescribed drug in their oral fluid or blood; or
- 5 (iii) while under the influence of intoxicating liquor or of a
6 drug to such an extent as to be incapable of having proper
7 control of the vehicle; or
- 8 (iv) at a speed that exceeded the speed limit applying to the
9 person by more than 30%; or
- 10 (v) in a way that put at risk the safety of a vulnerable road user;
11 or
- 12 (vi) with a person younger than 17 years old in the vehicle.
- 13 (2) For subsection (1) (b) (i), evidence may be given of the concentration
14 of alcohol in the person's blood or breath based on—
- 15 (a) for proof of the concentration of alcohol in the person's blood
16 or breath—an analysis of a sample of the person's breath carried
17 out in accordance with the *Road Transport (Alcohol and Drugs)*
18 *Act 1977*; or
- 19 (b) for proof of the concentration of alcohol in the person's blood—
20 an analysis of the sample of the person's blood carried out at an
21 approved laboratory and certified accurate by an analyst in
22 accordance with the *Road Transport (Alcohol and Drugs)*
23 *Act 1977*.
- 24 (3) For subsection (1) (b) (ii), evidence may be given that a person has a
25 prescribed drug in the person's oral fluid or blood based on—
- 26 (a) for proof of presence of a prescribed drug in the person's oral
27 fluid—an analysis of a part of a sample of the person's oral fluid
28 under the *Road Transport (Alcohol and Drugs) Act 1977*,
29 section 13G (Oral fluid—confirmatory analysis) that indicates
30 that a prescribed drug is present in the sample; or

- 1 (b) for proof of the presence of a prescribed drug in the person's
2 blood—an analysis of a part of a sample of the person's blood
3 under the *Road Transport (Alcohol and Drugs) Act 1977*,
4 section 15A (Analysis of blood samples) that indicates that a
5 prescribed drug is present in the sample.
