A Bill for

An Act to amend legislation about justice and community safety, and for other purposes

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1 **Part 1 Preliminary**

2 **1 Name of Act**

3 This Act is the *Justice and Community Safety Legislation Amendment*
4 *Act 2023 (No 2)*.

5 **2 Commencement**

- 6 (1) This Act (other than the following provisions) commences on the day
7 after this Act's notification day:
- 8 • part 6
 - 9 • section 54
 - 10 • schedule 1, part 1.7.

11 *Note* The naming and commencement provisions automatically commence on
12 the notification day (see [Legislation Act](#), s 75 (1)).

- 13 (2) Part 6 commences immediately after the commencement of the
14 *Discrimination Amendment Act 2023*, section 9.

- 15 (3) Section 54 commences on a day fixed by the Minister by written
16 notice.

17 *Note* A single day or time may be fixed, or different days or times may be
18 fixed, for the commencement of different provisions (see [Legislation Act](#),
19 s 77 (1)).

- 20 (4) If section 54 has not commenced within 18 months beginning on this
21 Act's notification day, it automatically commences on the first day
22 after that period.

- 23 (5) The [Legislation Act](#), section 79 (Automatic commencement of
24 postponed law) does not apply to section 54.

- 2 (a) the commencement of the *Planning (Consequential*
