## **Appropriation (Office of the Legislative Assembly) Bill 2023-2024 (No 2)**

### **A Bill for**

An Act to appropriate additional money for expenditure in relation to the Office of the Legislative Assembly for the financial year that began on 1 July 2023

---

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1   **1           Name of Act**

2                   This Act is the *Appropriation (Office of the Legislative Assembly) Act*  
3                   2023-2024 (No 2).

4   **2           Commencement**

5                   This Act commences on the day after its notification day.

6                   *Note*        The naming and commencement provisions automatically commence on  
7                   the notification day (see [Legislation Act](#), s 75 (1)).

8   **3           Purposes of Act**

9                   This Act is made for the purposes of—

- 10                   (a) the Self-Government Act, section 57 and section 58; and  
11                   (b) the *Financial Management Act 1996*, section 6 and section 8.

12   **4           Meaning of *financial year***

13                   In this Act:

14                   *financial year* means the year that began on 1 July 2023.

15   **5           Terms used in Financial Management Act 1996**

16                   A term used in the *Financial Management Act 1996* has the same  
17                   meaning in this Act.

1 **6 Additional appropriation of \$94 000 for Office of the**  
2 **Legislative Assembly**

3 The amount mentioned in table 6, column 1 is appropriated to the  
4 Office of the Legislative Assembly for additional payments to be  
5 made by the office on behalf of the Territory in the financial year.
