# Crimes (Sentence Administration) Amendment Bill 2024

## A Bill for

An Act to amend the Crimes (Sentence Administration) Act 2005

The Legislative Assembly for the Australian Capital Territory enacts as follows:

2			This Act is the Crimes (Sentence Administration) Amendment Act 2024.

5			This Act commences on the 7th day after its notification day.
