## Appropriation Bill 2024-2025 (No 2)

---

### A Bill for

An Act to appropriate additional money for the purposes of the Territory for the financial year that began on 1 July 2024

---

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1   **1       Name of Act**

2       This Act is the *Appropriation Act 2024-2025 (No 2)*.

3   **2       Commencement**

4       This Act commences on the day after its notification day.

5       *Note*     The naming and commencement provisions automatically commence on  
6               the notification day (see [Legislation Act](#), s 75 (1)).

7   **3       Purposes of Act**

8       This Act is made for the purposes of—

- 9       (a) the [Self-Government Act](#), section 57 and section 58; and  
10      (b) the [Financial Management Act 1996](#), section 6 and section 8.

11  **4       Meaning of *financial year***

12      In this Act:

13      *financial year* means the year that began on 1 July 2024.

14  **5       Terms used in Financial Management Act 1996**

15      A term used in the [Financial Management Act 1996](#) has the same  
16      meaning in this Act.

17  **6       Additional appropriations of \$387 714 000**

- 18      (1) If a territory entity is mentioned in a part of schedule 1, column 1—  
19          (a) the amount mentioned in that part, column 2 is appropriated to  
20             the territory entity for additional net controlled recurrent  
21             payments in the financial year for the territory entity; and  
22          (b) the amount mentioned in that part, column 3 is appropriated to  
23             the territory entity for additional payments to be made on behalf  
24             of the Territory in the financial year for the territory entity.

1           (2) The amount mentioned in schedule 1, part 1.6 (Treasurer's advance),  
2           column 4 is appropriated to the Treasurer's advance for the *Financial*  
3           *Management Act 1996*, section 18.

4   **7           Commonwealth grants**

5           The *Financial Management Act 1996*, section 17 applies to all  
6           appropriations mentioned in schedule 1 except the appropriation to  
7           the Treasurer's advance.
