# **Better Regulation (Repeal of Legislation) Bill 2025**

## **A Bill for**

An Act to repeal certain legislation

---

The Legislative Assembly for the Australian Capital Territory enacts as follows:

1 **1 Name of Act**

2 This Act is the *Better Regulation (Repeal of Legislation) Act 2025*.

3 **2 Commencement**

4 This Act commences on the day after its notification day.

5 *Note* The naming and commencement provisions automatically commence on  
6 the notification day (see [Legislation Act](#), s 75 (1)).
