MOTOR TRAFFIC ACT 1936

DETERMINATION OF FEES

Under Section 217A of the Motor Traffic Act 1936, I REVOKE, with effect from 29 September 1989, the determination of fees under Section 163C(2) of the Act notified in the Gazette of 25 July 1989, No S14, and DETERMINE, that the determined fee for the issue of a parking voucher from a voucher machine located at a site specified in the Schedule shall be the amount specified in the Schedule in relation to that site.

I SPECIFY, that for the purposes of Subsection 163C(1) of the Act, the period in relation to a voucher machine located at a site specified in the Schedule shall be the period specified in the Schedule in relation to that site.


