
Fee payable prior to registration or renewal of registration under section 14, or section 8(1):

(i) where the vehicle weighs 2000kg or less \$150.00


(ii) where the vehicle weighs more than 2000kg but not more than 4000kg \$150.00 plus \$54.00 for each 250kg or part of 250kg by which the vehicle's weight exceeds 2000kg

(iii) where the vehicle weighs more than 4000kg \$582.00 plus \$32.00 for each 250kg or part of 250kg by which the vehicle's weight exceeds 4000kg
