MOTOR TRAFFIC ACT 1936

DETERMINATION No. 122 OF 1992

Under Section 217A of the Motor Traffic Act 1936, I REVOKE all previous determinations of fees so far as they are payable for the purposes of the following Sections of the Act;


8(1)      14(a)      14(c)      22(3)      105(4)

I DETERMINE that the fees payable for the purposes of those Sections shall be in accordance with the Schedule.

Except as provided below, this instrument commences operation on 1 August 1992.

The provisions of Parts 2 and 4 of this instrument determining fees in respect of the renewal of registration of vehicles apply to vehicles currently registered under the Act where the registration expires on or after 1 August 1992 with effect from the date of notification of this instrument in the Gazette.
