NATURAL HISTORY.**

NAME	ORIGIN	SIGNIFICANCE
WILSON CRESCENT	Herbert Wilson (1877-1955)	Teacher, Soldier, Naturalist. Born in Yorkshire, England, he was brought to Australia in 1883 and 1894 began teaching in remote areas of Victoria where he became fascinated by natural history. After further study he became lecturer in nature study at Melbourne Training College. During WWI he served at Gallipoli, in France and in Egypt, was promoted to Major, was awarded the OBE, MC and the Belgian Croix de Guerre. In 1922 he shared the McBain research fellowship in botany. From 1927- 52 he lectured in botany at the Victorian College of Pharmacy. He was the founder of the Gould League of Bird Lovers. He was awarded the Natural History Medallion in 1943. Mammologist.

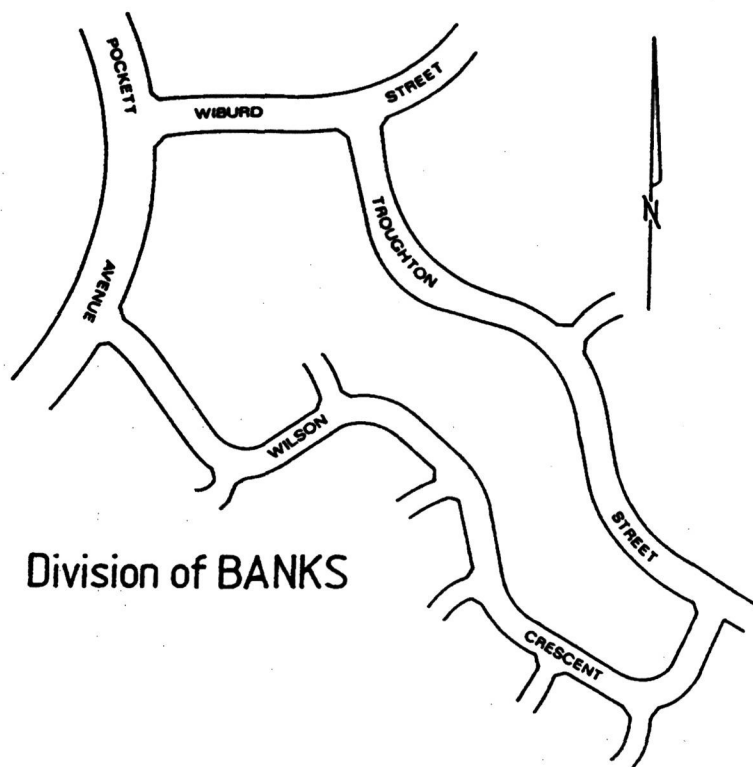
