DETERMINATION OF FEES

No. 53 of 1993

EXPLANATORY STATEMENT

This instrument revokes all existing fees determinations under the Agents Act 1968 relating to fees payable in respect of the issue and renewal of licence and registration fees payable in relation to real estate agents, stock and station agents, business agents and travel agents.

This determination does not indicate the determinations that it is revoking nor the dates of their publication in the Gazette. A general revocation clause has been used as each of the previous determinations contained some errors, and to make references to them would create more problems for the future.

Increases are based on a 3% CPI adjustment for 1993/94. Fees under sections 41A, 54A and 110 have been increased by 3% and rounded to the nearest dollar. Fees payable for miscellaneous services (sections 93(6), 93(11) and 110) have been increased by 3% and rounded to the nearest five cents.

This instrument (copy attached) sets fees for the purpose of the Agents Act 1968 including:

- annual fees payable by a real estate agent, stock and station agent or business agent to be paid in respect of a company as well as an individual;
- the payment of fees where a travel agent elects to increase or decrease the number of places of business; and
 - the payment of a fee for the issue of an amended licence.

The fees are set out below, with previous rates shown in brackets.
