#### b. Reservation Fees

The Reservation Fees, which comprise the Allotment and Maintenance Fee is payable when a Certificate of Reservation is purchased. It entitles the certificate holder to an Exclusive Right of Burial at some time of future need and is for a period of tenure of 25 years. At each time of need, the Maintenance Fee is payable at pro-rata, and entitles the Exclusive Right of Burial holder to a period of tenure of 50 years from the date of the last interment.

Reservation of an Adjacent Allotment at time of Burial, or an Unspecified Allotment (limit of one allotment)

Allotment Fee	- as above
Maintenance Fee	- as above

Reservation of a Specific Allotment in established part of Cemetery

Allotment Fee	- as above plus 50% surcharge
Maintenance Fee	- as above

#### Renewal of Exclusive Right of Burial or Certificates of Reservation

Exclusive Rights of Burial and Certificates of Reservation may be renewed or extended at any time during the period of tenure, but will lapse if not renewed prior to the expiration of tenure.

### Part 5 – Definitions

#### Coffin/Casket Sizes:

- a. Regular size coffin or casket – 2130mm x 710mm or less.
- b. Any coffin or casket which exceeds 2130mm x 710mm is classified as oversize.

#### Allotment Depths:

- a. Single Depth 1.5m
- b. Double Depth 1.8m; and
- c. Triple Depth 2.3m

It should be noted that a standard allotment is 1.8m deep. If a single depth allotment (1.5m) is specifically requested it will be charged at the same rate as a standard (double depth) allotment.

#### Plaque Sizes:

- a. Single Bronze Plaque – 380mm x 215mm
- b. Double Bronze Plaque – 380mm x 215mm
- c. Detachable Plate for b. above
- d. Chrome Plaque – 90mm x 115mm
- e. Bronze Plaque (Jewish) – 380mm x 280mm
- f. Memorial Gardens Plaque – 180mm x 120mm
- g. Babies Rose Garden – 140mm x 70mm; and
- h. Wall of Remembrance – 138mm x 103mm
