b. Reservation Fees

A Certificate of Reservation can be purchased entitling the Certificate Holder to an Exclusive Right of Burial at some time during the next 25 years. At the time of purchase of the Certificate, the relevant Allotment Fee and Maintenance Fee must be prc-paid. At the first, or subsequent interments a Maintenance Fee is payable to extend the maintenance period to a full 50 years after the last interment.

Reservation of an un-specified allotment, or the adjacent allotment at the time of a burial (limit of one allotment):

No Reservation Fee.

Reservation of a Specific Allotment in an established part of Cemetery:

Reservation Fee = 50% of relevant allotment fee.

Exclusive Right of Burial and Cerificates of Reservation are renewable but will lapse if not renewed prior to the expiration of tenure.
