BUILDING ACT 1972

ADOPTION AND MODIFICATION OF THE BUILDING CODE OF AUSTRALIA

NO. 118 OF 1995

Pursuant to section 24 of the *Building Act 1972*, I hereby revoke the instrument of adoption and modification of the Building Code dated 21 October 1994, notified in Special Gazette No S235 of 1 November 1994 and published as Determination No 142 of 1994 and adopt all of the provisions of the Building Code of Australia prepared and published by the Australian Uniform Building Regulations Co-ordinating Council with the modifications specified in the Schedule to this notice. The provisions of the Building Code of Australia adopted by this notice do not apply to plans for the erection or alteration of a building lodged before the date on which it comes into effect
