


BOOKMAKERS ACT 1985

NO. 18 OF 1996

Pursuant to Section 39B (2) of the *Bookmakers Act 1985*, I DETERMINE that the directions for the operation of the sports betting venue at the Bruce Outdoor Stadium shall be as set out in the attached schedule.

**OPERATIONAL INSTRUCTIONS FOR THE SPORTS BETTING VENUE AT
THE BRUCE OUTDOOR STADIUM**

- 1 Times of betting
 - 1.1 The determined betting venue shall only open on 15 March 1996
 - 1.2 Invited sports bookmakers shall field at the determined sports betting venue at the Bruce Outdoor Stadium between the following times.-
 - 1 2 1 For face to face betting on approved sports betting events.-
4 30 pm to 9.00 pm
- 2 Hours of attendance
 - 2 1 Between the times outlined above, invited sports bookmaker must, subject to the consent of the Manager of the venue, attend at the Bruce Outdoor Stadium either by way of an agent who holds a sports betting agent's licence, or
 - (a) in the case of an individual bookmaker - in person,
 - (b) in the case of a syndicate - by a member of the syndicate, or
 - (c) in the case of a company - by a director who holds a bookmakers standing licence.
- 3 Methods of betting
 - 3 1 Sports bookmakers are only permitted to accept face-to-face bets at the Bruce Outdoor Stadium
- 4 Ticketing
 - 4 1 In respect of all bets, sports bookmakers are required to issue a ticket to a punter in a form that displays the details of the bet, the amount of the bet, the amount to be won by the punter and the name of the bookmaker
 - 4 2 In the case of bets on thoroughbred, harness or greyhound events, the nature of the bet - Win only, Each Way, Place only, Double or Quinella is to be clearly indicated

4 3 Tickets are to be in a form that will ensure that the details printed on the ticket will not deteriorate, fade or become unreadable over the period of the contingency or within a period of 28 days thereafter

4 4 Thermal ticket printers are not permitted to be used in the Bruce Outdoor Stadium

5 Lost tickets

5 1 In the event of the loss of a sports betting ticket, the details of the bet and the name of the bookmaker concerned is to be forwarded to the following -

5.2 On receipt of the relevant information, the matter shall be investigated and appropriate follow up action initiated

6 Bookmakers Stand

6 1 Each sports bookmaker shall keep the bookmakers stand at the approved sports betting venue clean and tidy at all times.

7 Audit and Financial Arrangements

7 1 The audit and financial arrangements at the Bruce Outdoor Stadium are as specified in Determination No 157 of 1995, published in Special Gazette No S279 of 6 November 1995.

8 Security Guarantee Arrangements

8 1 The security guarantee arrangements at the Bruce Outdoor Stadium are as specified in Determination No 157 of 1995, published in Special Gazette No S279 of 6 November 1995
