DETERMINATION No. 251 OF 1997

REGISTRATION OF MOTOR VEHICLES

Under section 217A of the *Motor Traffic Act 1936* (the Act) I revoke Determination No 245 of 1997 dated 4 November 1997 and notified in the Gazette No. S338 of 4 November 1997 and I determine that:

- (a) the fee payable in respect of the sections of the Act specified in the Schedule shall be the fee specified in the Schedule for that section, and
- (b) the fee payable under section 12 of the Act in respect of the registration of a vehicle of a kind listed in Part 2 of the Schedule to the *Road Transport Charges (Australian Capital Territory) Act 1993* of the Commonwealth shall be the fee specified in the Schedule to the Commonwealth Act

This instrument commences operation on 1 December 1997
