## OPERATIONAL INSTRUCTIONS FOR THE SPORTS BETTING VENUE AT THE BRUCE OUTDOOR STADIUM

- 1 Times of betting
- 1.1 The determined betting venue shall only open on
- 1.1.1 8 February 1997 1.1.2 22 February 1997 1.1.3 15 March 1997
- 1.1.4 29 March 1997
- 1 1.5 12 April 1997
- 1 2 At the invitation of the Canberra Cosmos, sports bookmakers may field at the determined sports betting venue at the Bruce Outdoor Stadium between the following times -
- 1.2.1 For face to face betting on approved sports betting events:-
  - 5.30 pm to 9 30 pm
- 2 Hours of attendance
- 2 1 Between the times outlined above, invited sports bookmaker must, subject to the consent of the Canberra Cosmos, attend at the Bruce Outdoor Stadium either by way of an agent who holds a sports betting agent's licence, or.
  - (a) in the case of an individual bookmaker in person,
  - (b) in the case of a syndicate by a member of the syndicate; or
  - (c) in the case of a company by a director who holds a bookmakers standing licence
- 3 Methods of betting
- 3.1 Sports bookmakers are only permitted to accept face-to-face bets at the Bruce Outdoor Stadium
- 4 Ticketing
- 4.1 In respect of all bets, sports bookmakers are required to issue a ticket to a punter in a form that displays the details of the bet, the amount of the

bet, the amount to be won by the punter and the name of the bookmaker.

- 4.2 Tickets are to be in a form that will ensure that the details printed on the ticket will not deteriorate, fade or become unreadable over the period of the contingency or within a period of 28 days thereafter
- 4 3 Thermal ticket printers are not permitted to be used at the Bruce Outdoor Stadium
- 5 Lost tickets
- 5.1 In the event of the loss of a sports betting ticket, the details of the bet and the name of the bookmaker concerned is to be forwarded to the following:-
