DRIVERS' LICENCES

Under section 217A of the *Motor Traffic Act 1936* (the Act), I revoke Determination No. 125 of 1997 dated 24 June 1997 and notified in the Gazette No S194 of 26 June 1997, and Determination No 13 of 1998 dated 14 January 1998 and notified in the Gazette No S28 of 14 January 1998, and I determine that.

- (a) the fee payable in respect of the sections of the Act specified in the Schedule shall be the fee specified in the Schedule for that section, and
- (b) the fee payable for the purposes of Regulation 22 of the Motor Traffic Regulations made under the Act shall be the fee specified in the Schedule for that Regulation.


This instrument commences operation on 1 July 1998.
