DETERMINATION OF REGISTRATION FEES

Under section 217A of the *Motor Traffic Act 1936* (the Act) I revoke Instrument No. 251 of 1997 dated 21 November 1997 and notified in the Gazette No. S358 of 21 November 1997 and I determine that:

- (a) the fee payable in respect of the sections of the Act specified in the Schedule shall be the fee specified in the Schedule for that section; and
- (b) the fee payable under section 12 of the Act in respect of the registration of a vehicle of a kind listed in Part 2 of the Schedule to the Road Transport Charges (Australian Capital Territory) Act 1993 of the Commonwealth shall be the fee specified in the Schedule to the Commonwealth Act.

This instrument commences operation on 1 August 1998.


