### **INSTRUMENT No. 221 OF 1999**

### **PARKING CHARGES**

Under Section 217A of the *Motor Traffic Act 1936* (the Act) I revoke Determination No. 82 of 1999, dated 8 April 1999 and notified in the Gazette No. 18 of 5 May 1999.

I determine that the fees payable for the purposes of Subsection 163C(2) of the Act for the issue of a parking voucher from a voucher machine located at the site specified in the Schedule shall be the amount specified in the Schedule in relation to that site.

Under Subsection 163C(3) of the Act, I specify that, for the purposes of Subsection 163C(2) of the Act, the period in relation to a voucher machine located at a site specified in the Schedule shall be the period specified in the Schedule in relation to that site.

This instrument commences operation on the day of gazettal.
