## **DETERMINATION OF FEES**

# **INSTRUMENT NO. 345 OF 2000**

Under section 82 of the Food Act 1992, I MICHAEL MOORE, Minister for Health, Housing and Community Care:

- 1. revoke the Determination of Fees No. 10 of 1994, dated 16 February 1994, which was notified in Australian Capital Territory Gazette No. S25 on 22 February 1994,
- determine that the fees payable for the purposes of this Act shall be in accordance with the
  attached schedule (where the determined fee for the purposes of a particular provision of the
  Act specified in the left hand column of the Schedule, is the fee which is listed in the right
  hand column of the Schedule immediately opposite the reference to the particular provision of
  the Act), and
- 3. exempt charities, child care centres, health facilities, educational facilities, sporting clubs and benevolent institutions from the requirement to pay fees for an application for a Food Business Licence or for the renewal of a Food Business Licence or for an approval to structurally alter a food premise or for an approval to alter food processing appliances installed in a food premise.

#### CLASS 1

For the purposes of this schedule a Class 1 Food Business Licence may only be issued to businesses that present a low risk of causing food borne illness; taking into account the types of food handled, the amount of food handling and the amount of cooking taking place. Class 1 food businesses include sellers of raw vegetables, sellers of raw meat, sellers of bread, sellers of cakes, sellers of coffee, servers of coffee, sellers of ice-cream, servers of ice-cream, and sellers of prepackaged food.

### **CLASS 2**

For the purposes of this schedule a Class 2 Food Business Licence may only be issued to businesses that present a medium risk of causing food borne illness; taking into account the types of food handled, the amount of food handling and the amount of cooking taking place. Class 2 food businesses include sellers of cooked to order food, sellers of take-away food, restaurants, eating-houses, premises on which both raw and cooked food are prepared, sellers of food prepared for immediate consumption and sellers of hot food.

### **CLASS 3**

For the purposes of this schedule a Class 3 Food Business Licence may only be issued to businesses that present a high risk of causing food borne illness; taking into account the types of food handled, the amount of food handling and the amount of cooking taking place. Class 3 food businesses include catering services, food manufactures, food processors, preparers of food for elderly persons, preparers of food for children, transporters of hot food, transporters of high risk ready to eat food and preparers of food that is consumed at a place other than the place it is prepared.
