DANGEROUS GOODS ACT 1984

REVOCATION AND DETERMINATION OF FEES

INSTRUMENT No. 130 OF 2001

1. Pursuant to section 12A of the **Dangerous Goods Act 1984** (the Act) I **REVOKE** the Determination No 160 of 2000 dated 8 June 2000 notified in Special Gazette No S20 of 8 June 2000 and I **DETERMINE** that the fees for the purposes of the Act shall be in accordance with the Schedule.
2. The fees for services provided are specified in the Schedule hereunder in Column 2 and prices for 2001-2002 (GST inclusive, where applicable) are specified in Column 4 opposite, in relation to that service.
3. Explanatory notes (including the previous year's fee) are included in the Schedule. Explanatory notes are included at the end of the Schedule, where applicable. Headings and explanatory notes in the Schedule do not form part of the determination. (For example: where new fees for 2001-02 are denoted by an "N/A" in 2000-01, if included in the schedule, would not form part of the determination).

It should also be noted that section 4(1) of the Road Transport Reform (Dangerous Goods) Act 1995 (Cwth) establishes that the Road Transport Reform (Dangerous Goods) Act 1995 is taken to be a law made by the Legislative Assembly for the Territory under section 22(1) of the Australian Capital Territory (Self Government) Act 1988 (Cwth).
