COMBINED DETERMINATION OF FEES AND EXPLANATORY MEMORANDUM

Explanatory note: This document sets out fees under the *Electoral Act 1992*.

INSTRUMENT NO. 150 OF 2001

- 1. This clause comes into operation on the date on which this instrument is notified in the Gazette.
- 2. Under section 8 of the Electoral Act 1992, the Electoral Commission **REVOKES** Determination No.249 of 2000 (Combined Determination of Fees).
- 3. Under section 8 of the Electoral Act 1992, the Electoral Commission **DETERMINES** that the fees payable for the purposes of the Act are as set out in the Schedule.
- 4. Under section 8 of the Electoral Act 1992, the Electoral Commission **DETERMINES** that the fees payable for the purposes of the Act in item 17 may be exempted or refunded by the Electoral Commissioner where the copies are to be used for educational purposes.
- 5. Explanatory notes (including previous fees) are included in the Schedule in italic text. General explanatory notes are included at the end of the Schedule in italic text. Explanatory notes in italic text and general explanatory notes in italic text do not form part of the determination. The final fee for this component is made up of this base level fee and a \$0.02 GST component. Under paragraph 7(1)(g) of the <u>Electoral Act 1992</u>, the provision of copies of the following documents:

- An extract of the Register of Political Parties kept under section 88 of the Electoral Act;
- An application for registration of an eligible political party provided to the Electoral Commissioner under section 89 of the Electoral Act;
- A constitution of a political party provided to the Electoral Commissioner under section 89 of the Electoral Act;
- A notice of objection to an application to register a political party provided to the Electoral Commissioner under section 91 of the Electoral Act;
- A response to any notice or objection provided to the Electoral Commissioner under section 91 of the Electoral Act
- A notice of objection to an application to change or to add to the particulars registered in relation to a political party provided to the Electoral Commissioner under section 95 of the Electoral Act; and
- An application to change or to add to the particulars registered in relation to a political party provided to the Electoral Commissioner under section 95 of the Electoral Act.

The base level fee for between one and twenty A4 pages has been calculated at \$11.00. The final fee for this component is made up of this base level fee and a \$1.10 GST component. This replaces a fee of \$11.27 determined in 2000.

The additional A4 page component has been calculated at \$0.21. The final fee for this component is made up of this base level fee and a \$0.02 GST component. This replaces a fee of \$0.20 determined in 2000.

\$12.10 for between one and twenty A4 pages 23 cents for each additional A4 page
