NOTICE OF GUIDELINES ABOUT WITHDRAWAL OF INFRINGEMENT NOTICES

INSTRUMENT NO. 243 OF 2001

In pursuance of sub-section 32(1) of the *Road Transport (General) Act 1999*, I issue the guidelines in Schedule 1 (attached) for withdrawal of infringement notices that have been issued under the provisions of the Road Transport legislation listed in Schedule 2 (attached).

NOTICE OF GUIDELINES ABOUT WITHDRAWAL OF INFRINGEMENT NOTICES

Infringement notices may be withdrawn for the following reasons:

- If the infringement notice is incorrectly issued, including in the following circumstances:
 - where the information concerning the vehicle is incorrect; or
 - the type of offence specified is incorrect.
- If a valid parking permit or parking ticket is purchased, but incorrectly displayed and:
 - the person completes a Statutory Declaration detailing the type of permit or ticket purchased and steps taken to display it correctly; and
 - can provide the permit or ticket to the Road Transport Authority; and
 - the Road Transport Authority is satisfied that reasonable steps were made to display it correctly.
- If a vehicle is broken down or otherwise immobilised and:
 - the person completes a Statutory Declaration detailing events; and
 - the person provides evidence such as attendance from a motoring organisation such as the NRMA.
- If a vehicle is stolen or sold and:
 - the person completes a Statutory Declaration detailing events; and
 - Road Transport Authority or police records confirm the event.
- If the meter or ticket machine is faulty and:
 - the person completes a Statutory Declaration stating coinage used, time of arrival and departure at the parking machine; and
 - Road Transport Authority records confirm the fault.
- If inadequate parking signs are in place such as damaged or obscured signs and:
 - the person completes a Statutory Declaration detailing the situation; and
 - Road Transport Authority records or a site inspection confirm the inadequate signage.
- In an emergency medical situation, or similar event and:
 - the person completes a Statutory Declaration detailing the emergency medical situation or event; and
 - the emergency medical situation or event can be confirmed by a registered medical practitioner or by hospital records.
- For administrative reasons, for example in relation to deceased persons or overseas residents.
