ROAD TRANSPORT (GENERAL) ACT 1999
REVOCATION AND DETERMINATION OF FEES
REGISTRATION OF MOTOR VEHICLES AND TRAILERS
INSTRUMENT No. 29 OF 2001

Under section 96 of the **Road Transport (General) Act 1999** (the Act) I **REVOKE** Instrument No.184 of 2000, dated 19th June 2000 and notified in Gazette No. S25 on 20 June 2000, and I **DETERMINE** that:

- (a) the fee payable in respect of the provisions of the *Road Transport (Vehicle Registration) Regulations 2000* (the Regulations), made under the *Road Transport (Vehicle Registration) Act 1999*, and specified in the attached Schedule shall be the fee specified (including the Commonwealth Goods and Services Tax where indicated by asterisk (*)) in the Schedule for that provision; and
- (b) the fee payable for the purposes of subregulations 32(3) and 68(8) in respect of the registration of a vehicle of a kind listed in Part 2 of the Schedule to the *Road Transport Charges (Australian Capital Territory) Act 1993* of the Commonwealth, as amended by the *Road Transport Charges (Australian Capital Territory) Amendment Act 2000*, shall be the fee specified in the Schedule to the Commonwealth Act (shown on page 7 of the schedule to this determination).

The new fees will apply from 1 March 2001.
