## Disallowable Instrument DI 2002 — 131

made under the

*Dangerous Goods ACT 1975, Part 7, Section 46 – Determination of fees*

1. I **REVOKE** the Determinations Nos 130 and 131 of 2001 dated 12 June 2001 notified in the Special Gazette No S34 of 20 June 2001 and I **DETERMINE** that the fees for the purposes of the Act shall be in accordance with the Schedule.
