Machinery ACT 1949, Section 5 – Determinations of fees

1. I **REVOKE** the Determination No 135 of 2001 dated 12 June 2001 notified in the Special Gazette No S34 of 20 June 2001 and I **DETERMINE** that the fees for the purposes of the Act shall be in accordance with the Schedule.

Single Inspections

Notwithstanding any other provision of this paragraph, where in one day in any premises an inspection is made of:

- a) only on boiler and no pressure vessel, or
- b) only one pressure vessel and no boiler, and the boiler or pressure vessel inspected is one referred to in Inspection of Boilers subparagraph 2(a), and Inspection of Pressure Vessels subparagraph 1(a) and (b), and 2(a) and (b), the fee to be charged for the inspection shall be 50 percent in excess of the fee otherwise payable

Multiple Inspections

Notwithstanding any other provisions of this paragraph, where in any one day in any premises 5 or more boilers or 5 more pressure vessels are inspected, the fee to be charged for the inspection shall be 30 percent less than the fees otherwise payable.
