## **1 Revocation**

I revoke-

## Schedule

(a) The fee payable to the Commission by an applicant applying under section 7 of the Act for approval to conduct a lottery that is not a trade promotion, is, where the total prize value is listed in Table A, Column A, that corresponding fee in Column B.

Greater than 10,000 or less than or equal to 50,000	385.00
Greater than 50,000	550.00

The fee payable to the Commission by an applicant applying under section 7 of the Act for approval to conduct a lottery that is a trade promotion, is, where the total prize value is listed in Table B, Column A, that corresponding fee in Column B.

If an application is withdrawn prior to commencement of its assessment, the fee payable in this determination is refundable to the amount of that fee less \$35.

If an application is withdrawn or rejected following the commencement of its assessment, the fees in this determination are not refundable.

“Assessment” in this context means the consideration or analysis of an application to determine its eligibility under the Act, but does not include the registration or recording of the receipt of an application.

**Determination (b)** outlines that the fee payable to the Commission by the permit holder accompanying an application for a variation to an approval to conduct a lottery under section 7A of the Act is \$35.
